PUBLIC NOTICE

Guaynabo – Toa Baja Workforce Development Board is now accepting Training Provider Applications to be approved and added to the Eligible Training Provider List (ETPL) for Program Year 2023-2024

Section 122 of the Workforce Innovation and Opportunities Act of July 22, 2014, as amended, (hereinafter "WIOA") establishes the procedure for identifying training service providers. For this reason, the Local Board of the Guaynabo-Toa Baja Local Workforce Development Area invites Public and Private Educational Institutions, and Community-Based Organizations to submit and complete applications for initial or subsequent eligibility as training service providers.

Entities interested in belonging to the Eligible Training Providers List (ETPL), of the Innovation and Opportunities of the Labor Force for the PY 2023-2024, must request their inclusion through the software Participant Record Information System (PRIS). In order to use the system, you must request access through the mail: prisdddec@ddec.pr.gov. PRIS will assign you a registration number that will be always used for your identification.

The Training Service Providers who had previous participation will continue to use for these purposes the Module of the State List of Eligible Training Service Providers (ETPL) integrated to the (PRIS), with the user code previously provided.

The deadline to enter or modify program service in the Participant Record Information System (PRIS) is April 30, 2023 (Subject to change).


Those interested in entering to the Eligible Training Providers List (ETPL), should also request the Specification Guide for the State List of Training Service Providers by email to the following address: juntalocal@gtbwioa.com. Local Board staff will provide you with orientation and everything you need to submit your application. The guide also refers to the request documents, such as: evidence of your employer social security and the license granted by the Department of State, Office of Registration and Licensing of Educational Institutions, Curricular Content, Board of Post-secondary Institutions as applicable.

All questions related to the specifications can be made in writing to juntalocal@gtbwioa.com or at (787) 720-4040 ext. 6480. The delivery must be made in accordance with the Specifications Guide for the Submission of Proposals.

The Local Board invites Service Providers to submit offers that are linked to the high occupational demand, with a capacity to achieve the established performance goals. The Occupational Trainings that are included in the State List may not be included in other Registries of the Programs under Title I of the WIOA of the Local Board. Providers are requested to establish whether their offerings are prepared for distance learning (online or via the Internet).

Once the PRIS registration application is filed, interested Training Service Providers must submit their proposal with all the documentation required in the Specifications Guide by email to the following address: juntalocal@gtbwioa.com
